A BY-LAW OF THE

WETASKIWIN PUBLIC SCHOOL DISTRICT NO. 264

RELATING TO THE FORMATION OF A REGIONAL DIVISION
TO BE CALLED THE WETASKIWIN REGIONAL DIVISION

WHEREAS Division 2.1 (s.208.1 to 208.6) of the School Act permits two or more districts, divisions, counties or other areas governed by boards to enter into an agreement for the establishment of a regional division;


AND WHEREAS The Board of Trustees of Wetaskiwin Public School District No. 264 and The County of Wetaskiwin No. 10 will be entering into such an agreement to form a regional division to be called the Wetaskiwin Regional Division (hereinafter called the "Regional Division").


AND WHEREAS the Board and County must each pass a by-law that approves the establishment of a regional division and the inclusion of its area in the regional division;

NOW THEREFORE The Board of Trustees of the Wetaskiwin Public School District No. 264 (hereinafter called the "Board") enacts as follows:


1. The Board approves the establishment of the Regional Division and the inclusion of the area comprising the Wetaskiwin Public School District No. 264 in the Regional Division.







BY-LAW NUMBER 94/26

BY-LAW NO. 94/26 is a by-law of the County of Wetaskiwin No. 10 in the Province of Alberta, to authorize the establishment of electoral subdivisions of the County of Wetaskiwin No. 10 to be included in a regional division to be called the Wetaskiwin Regional Division.

WHEREAS: Division 2.1 (s.208.1 to 208.6) of the School Act permits two or more districts, divisions, counties or other areas governed by boards to enter into an agreement for the establishment of a regional division;

AND WHEREAS: The Board of Trustees of Wetaskiwin School District No. 264 and The County of Wetaskiwin No. 10 (hereinafter called the "Participating Boards") will be entering into such an agreement to form a regional division to be called the Wetaskiwin Regional Division (hereinafter called the "Regional Division");

AND WHEREAS: The County will be entering into an Agreement (hereinafter called the "Regional Agreement") with The Board of Trustees of Wetaskiwin School District No. 264. This Regional Agreement provides for the establishment of the Regional Division and the inclusion in the Regional Division the area included in The County of Wetaskiwin No. 10 for school purposes.

AND WHEREAS: The Board of Trustees of the Regional Division shall be comprised of seven (7) trustees. Relying upon 1993 census information, the total population of the Regional Division is 21,104. Representation by population shall require each trustee to represent approximately 2,000 to 3,500 people;

AND WHEREAS the wards of the Regional Division shall be:

- (a) The Wetaskiwin School District No. 264 (pop: 9,155) (Number of Trustees 3)
- (b) The County of Wetaskiwin No. 10 (pop: 11,949) (Number of Trustees 4);


NOW THEREFORE: The County of Wetaskiwin No. 10 (hereinafter called the ("County")) enacts as follows:

1. In accordance with s.208.3(3) of the School Act, The County of Wetaskiwin No. 10 is hereby dividing its ward into electoral subdivisions, as follows:

- (a) Electoral Subdivision #1 - Population 3136 (1 Trustee)

All that portion of the County of Wetaskiwin No. 10 contained within the boundary as follows: commencing at the north east corner of the east boundary of the County of Wetaskiwin No. 10 thence south along the east boundary to the south boundary of the County; thence west along the south boundary to Highway 2; thence north along Highway 2 to the local road known as Hillside Road; thence east along the local road known as Hillside Road to Secondary Highway 814; thence north along Secondary Highway 814 to the County boundary; thence east along the north boundary to the point of commencement.

(b) Electoral Subdivision #2 - Population 3168 (1 Trustee)

All that portion of the County of Wetaskiwin No. 10 contained within the boundary as follows: commencing at the north east boundary of range 24 thence south along Secondary Highway 814 to the south east corner of the south east quarter of section 13, township 47, range 24, west of the 4th meridian; thence west along the local road known as Hillside Road to Highway 2; thence north along Highway 2 to the north boundary of the County; thence east along the north boundary to the point of commencement.

(c) Electoral Subdivision #3 - Population 2924 (1 Trustee)

All that portion of the County of Wetaskiwin No. 10 contained within the boundary as follows: commencing at the north east corner of the north west quarter of section 33, township 47, range 25, West of the 4th meridian and proceeding south along Highway 2 to the south boundary of the County; thence west along the south boundary to Secondary Highway 771; thence north along Secondary Highway 771 to the south east corner of the NW quarter of section 22, township 46, range 1, west of the 5th meridian; thence proceeding north along the west boundaries of sections 22 and 27, township 46, range 1, west of the 5th meridian; thence south easterly along Pigeon Lake boundary to the north east corner of the SE quarter of section 13, township 46, range 1, west of the 5th meridian; thence south to the north west corner of section 9, township 46, range 28, west of the 4th meridian; thence following the south, east and north boundaries of the Pigeon Lake Indian Reserve No. 138 A; thence north westerly along Pigeon Lake boundary to the south west corner of the SE quarter of section 14, township 47, range 1, west of the 5th meridian; thence north along the County boundary to the north boundary; thence east along the north boundary to the point of commencement.

(d) Electoral Subdivision #4 - Population 2721 (1 Trustee)


All that portion of the County of Wetaskiwin No. 10 contained within the boundary as follows: commencing at the north east corner of the NE quarter of section 28, township 46, range 1, west of the 5th meridian proceeding south along the east boundaries of sections 28 and 21, township 46, range 1, west of the 5th meridian and continuing south along Secondary Highway 771 to the south boundary of the County; thence west along the southern boundary to the west boundary of the County; thence north along the western boundary to the north boundary of the County; thence east along the north boundary to Pigeon Lake; thence south easterly along the boundary of Pigeon Lake to the point of commencement.


2. This By-law shall be attached to and become a part of the Regional Agreement to be entered into by the Participating Boards establishing the Regional Division.




